- DISCUSS/CONSIDER & ACT ON CREATING A HIRING/FIRING POLICY Human Resource Manager Raquel Yanez explained to City Council the current policy created by administration and that was in place, according to the directive city council gave Interim City Administrator in September of 2018 and currently in practice. Mayor Obregon asked legal counsel about who had authority to hire and fire, Mr. Maldonado replied that under General Law Type A, the City Council has the authority unless they delegate it. Mr. Jordan replied to the Council that as of September of 2018 the city council had delegated the authority to hire & fire personnel below department heads to the City Administrator. Council Member Place 2 Joanne Rodriguez questioned if the past practice was that city council hired and terminated personnel, she wanted to know when the policy changed and why was it changed. Interim City Admin Mr. Jordan informed Council woman Rodriguez that he requested the authority from council and it was approved. Motion made by Council Member Place 3 Alicia Machado to create a policy and bring back to city council for final review and approval Motion seconded by Council Member Place 1 Alexandria Inocencio All in favor Motion carries unanimously

Mayor Obregon questioned City Secretary is this process had to do with an open record filed by Gilbert Ortiz and City Secretary replied no, it is strictly to comply with the Texas Election Code.
