DELIBERATE THE APPOINTMENT, EMPLOYMENT, EVALUATION, REASSIGNMENT, DUTIES, DISCIPLINE, OR DISMISSAL OF A PUBLIC OFFICER OR EMPLOYEE, REGARDING ARNOLD ZEPEDA, PARKS CREW LEADER Mr. Alvarez began by informing council of the accidents Mr. Zepeda had while on duty and 1 off duty. Mr. Alvarez stated that procedures for accidents had been followed and that all results both times had been negative. Mr. Alvarez informed council that Arnold would not be able to drive due to doctor recommendation and that at this point it would be a waste to have someone drive him around. Arnold told council that he had a black out when he was smoking back in January but he had quit because he had a reaction with the cigarettes and medication he was taking. He also told council that the minor accidents he had were because he thought he was going to clear the turns and ended up not making it and they wear minor, he added that he knew of other employees that didn't report accidents and that for reporting and doing the right thing he had been placed on the agenda. Mrs. Machado asked what the policy requirement was for driving and Mr. Alvarez responded that all employees had to have a class c driver's license as per job description. Council Member Place 2 Gilbert Eguia added that Arnold was a good employee and loyal and didn't give problems and he thanked him for being honest. Mr. Eguia added that he felt Arnold should be given reasonable accommodations for any medical condition. Mr. Alvarez stated that he wanted it to be clear and for the record that his complaint wasn't against Arnold it was for safety purposes for him and other employees, due to the accidents he has had he wouldn't be able to defend city because he was aware that there was a problem of safety violations, in other words if council decided to keep Arnold employed and something tragic were to happen, city would be liable because the city was aware of safety concerns and did nothing about it. He also stated that his recommendation was to terminate the employment, Arnold had been given opportunity to do further testing for healthy reasons and he had refused so

if he wasn't willing to cooperate he couldn't see where he would be able to assign someone to drive him around and waste the other employees time. It was because of all these facts he would recommend termination. Mrs. Machado stated that she would be fine to suspend without pay for Arnold to take care of what he needed or he could use leave if he had it to take care of the exams and further health test.

Motion made by Council Member Place 3 Alicia Machado to place Arnold Zepeda Parks Crew Leader on administrative leave without pay, Arnold may use sick leave or vacation leave to conduct a sleep apnea study and be released from doctor to return with no restrictions for 10 days or as long as doctor said it would be necessary to conduct study.
